## GENERAL INFORMATION

Please fill out the Registration Form completely, and return with your Registration Fee (multiple registrations can be combined on one check). You will need to provide a copy of:

- Birth Certificate
- Social Security Card
- Immunization Record
- Baptismal Certificate (Catholics only)

If the child is transferring from another school, you **MUST** include a copy of their most recent report card, test scores, discipline record (if any), and 504 plan (if any). This information has to be received before acceptance will be given.

Once registration has exceeded an acceptable class size, your child may be placed on a waiting list. This is necessary to plan for the coming school year to determine the number of teachers needed and books/materials to order.

Tuition will be due by Wednesday, May 6. If you plan to pay by loan, you may fill out the form and include it with your registration. It will be sent to First American Bank in April for processing.

## REFUNDS

Registration and Student Fees are non-refundable. If a student leaves the school after tuition is paid or a loan application is signed, tuition will be refunded according to the following schedule:

- Departure prior to June 1 - 90% refund of tuition
- Beginning June 1, and additional 10% will be subtracted the first of each month thereafter.

## LOANS

A student tuition financing program is available to all parents through First American Bank. You may finance up to 100% of the school year tuition and fees (not registration fees). Loan applications are filled out by parents and returned to St. Peter Chanel to be sent to First American Bank in April.

Each loan will be amortized over a ten (10) month period, with their first payment beginning July 1. If a parent wishes their loan to be amortized over an eleven (11) month period, prior approval by the Principal must be granted, with the first payment beginning June 1. Should any parent elect to pay cash for tuition after the note has been signed, it can be paid at no charge before May 6. After that date, a minimum \$25 prepayment charge will be assessed by the bank. All loans must be applied for and signed by May 6, since tuition is due on this date. Failure to meet this deadline will result in a late charge of \$250.

Any parent whose child is registered after July 31 and wishes to participate in this program, may do so. For parents who register after the deadline, the maturity date of April 1 will remain the same, and the number of months for amortization will be decreased accordingly.
